

July 6, 2011

The Saratoga Town Board met at 6:00 p.m. in the town office. Chairman Rickaby called the meeting to order. All members were present. The meeting was officially noticed.

Frank made a motion to accept the minutes for June 15, 2011. Forbes seconded it. Motion passed.

Scott Bernette, Grand Rapids Fire Chief, gave the 2nd quarter report. They responded to 9 calls in the 2nd quarter. He went over training they have been to and other department information.

Four road base bids were received and opened. Bids were as follows: Bohn Trucking and Excavating, Inc – \$9.05/ton, Ladick Road Materials, Inc. - \$8.48/ton, Haessly & Haessly, Inc. - \$8.55/ton, B & R Excavaing, LLC. - \$8.60/ton. Passineau made a motion to accept the bid from Ladicks Road Materials, Inc. Forbes seconded it. Motion passed.

Two bids for razing the house at 9598 County Road Z were received. Bids were as follows: Altmann Construction Company, Inc. - \$3,970, Bohn Trucking & Excavating, Inc. - \$4173.00, plus extra added to take care of the concrete footings and blocks. Forbes made a motion to go with Altmann Construction Company as long as they hauled in some black dirt and put grass seed where the house was taken down. Heeg seconded it. Motion passed.

Frank made a motion to grant an operator's license for Charlene Bjerk and Sadie Zolnik. Forbes seconded it. Motion passed.

Forbes made a motion to grant the Class B Beer and Class C Wine license for Robb Rose at Deer Trail Park Campground. Heeg seconded it. Motion passed.

Forbes made a motion to grant the Mobile Home park licenses good until June 30, 2012 for Richard DuBois for St. James, Park Place and Boardwalk Mobile Home Parks. Frank seconded it. Motion passed.

Matt Glinski, 6911 Fairview Lane, requested a variance for his driveway. He wanted to have concrete all the way to the edge of the road. He filled out paperwork and is aware that if the Town needs to do roadwork he is responsible for the cost of removing and replacing the driveway within the road right of way. Frank made a motion to grant the variance. Heeg seconded it. Motion passed.

Dave Ryun gave the Constable's report. A ticket was sent to Jesse Scheid since he has brought another semi onto property to be used for storage.

Complaints were received about the building inspector. A closed session meeting will be held July 13, 2011 at 6:00 p.m. to discuss what steps the board will take.

Billie-Jo Kester gave the Treasurer's report.

Forbes made a motion to pay the bills. Frank seconded it. Motion passed.

Correspondence was read.

Frank made a motion to adjourn the meeting. Passineau seconded it. Motion passed.
